The Kenwood HUG-PTO, its members, directors, agents, representatives and/or volunteers ("HUG-PTO") are not responsible for any injury, loss, or damage of any kind sustained by any person while participating in the Kenwood Krawl ("Krawl"), including injury, loss or damage which may be caused by the negligence of the HUG-PTO.
- Photography Release.** I, as the subject of photographs taken in the Krawl, hereby consent to and authorize the use and production of the photographs by the HUG-PTO. These same photographs may be used for any purpose including, but not limited to, promotion, advertising and public relations without further compensation or consent.
- Assumption of Risks.** In consideration of my participation in the Krawl, I acknowledge that I am aware of the possible risks, dangers and hazards associated with my participation in the Krawl (including the possible risk of severe or fatal injury to myself or others).
